

MyTax.DC.gov User Guide: Requesting a Clean Hands Certificate on the <u>MyTax.DC.gov</u> for Businesses and DC Residents

All businesses and DC residents **must** log-in to <u>MyTax.DC.gov</u> profile in order to request the **Certificate of Clean Hands**. **Instructions:**



- 1. From the MyTax.DC.gov homepage, enter your "Username" and "Password".
 - a. Then, click "Log In"

Please Note: Any agency requesting to validate your Certificate of Clean Hands will need the <u>Notice Number</u> and the <u>last four digits of the SSN</u>, displayed on the top right corner of the Certificate, as seen above (circled and highlighted).
