1. <u>AUTHORIZATION</u>

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700 and 1701 and 2005.2(b)

2. MINIMUM NEED

The District of Columbia Office of the Chief Financial Officer, Office of Contracts (District), on behalf of the Office of Financial Operations and Systems (OFOS) is seeking printing services to produce the District's Comprehensive Annual Financial Report (CAFR) and the Popular Annual Financial Report (PAFR).

3. ESTIMATED REASONABLE PRICE

The estimated fair and reasonable contract amount for this extension period from January 8, 2021 through June 30, 2021 is not-to-exceed \$100,000.00, based on the Contractor's rate and District estimated usage. The contractor's pricing was determined fair and reasonable based on market research and historical data gathered and analyzed by the Office of Financial Operations and Systems.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

Balmar, Inc. dba HBP is the incumbent Contractor and has satisfactorily provided the required services for five (5) years under contract CFOPD-16-C-013A. The contract was competitively awarded on January 8, 2016 to Balmar, Inc. dba HBP who responded to the

solicitation and was deemed qualified to provide all the requirements and the best value to the District of Columbia. The contract term included a one (1) year base period with four (4) one (1) year option periods. During the contract term Balmar, Inc. dba HBP has provided printing, production and publishing services for the Comprehensive Annual Financial Report and the Popular Annual Financial Report for submission to the DC Mayor, the DC Council and US Congress. Work begins in October and is fully completed in June of each year. The work schedule includes nights and weekends and facilitates the presentation of drafts of the CAFR and PAFR for review, formatting and to meet any printing requirements for the final reports as specified by the District. All work must meet any additional schedule needs and delivery deadlines required by the District throughout the duration of contract.

The District has an urgent and critical need for uninterrupted services for the printing, production and publishing requirements for the CAFR and the PAFR.

A sole source extension is the most advantageous method of fulfilling the District's need while completing the competitive procurement process and to allow time for a transition period from the existing contractor to a new contractor, if necessary, and to provide and method of alignment for the work and the period of performance of the contract. A market survey was not conducted because Balmar, Inc. dba HBP has agreed to continue services based on existing contract pricing.

Therefore, it is necessary to extend the contract through June 30, 2021 to facilitate and allow continuity of critical printing, production and publishing services for the CAFR and the PAFR for the District.

The Office of Contracts expects to award a new contract on or before June 30, 2021.
