1. <u>AUTHORIZATION</u>

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700 and 1701

2. MINIMUM NEED

The Government of the District of Columbia (District), Office of Lottery & Gaming (Agency OLG) has a minimum need for maintenance services of the Sports Wagering and Lottery Licensing System.

3. ESTIMATED REASONABLE PRICE

The contract period is from October 1, 2020 through September 30, 2021. The contract amount is \$743,000.00. The contractor's pricing was determined fair and reasonable based on market research.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

In February 2019, the Office of Lottery & Gaming (OLG), through a Memorandum of Understanding with the Department of Consumer and Regulatory Affairs (DCRA), began work to develop a Sports Wagering and Lottery Licensing System (the System) within the DCRA's DC Business Center portal using DCRA's vendor Limbic Systems, Inc. The System developed provides an online application process for Applicants seeking licensure by the OLG under the Sports Wagering Lottery Amendment Act of 2018 and Games of Skill Act of 2021.

OLG's MOU with DCRA expired at the close of Fiscal Year 2019. To continue development of the System in Fiscal Year 2020, the OLG leveraged DCRA's DC Business Portal Expansion Contract DCCR-2020-C-2001.

The OLG is seeking to continue engagement with Limbic Systems, Inc. in Fiscal Year 2021 to maintain the existing site and to continue development of the System,

including additional components supporting sports wagering, games of skill and charitable games.

Pursuant to the Sports Wagering Lottery Amendment Act of 2018, effective May 3, 2019 (D.C. Law 22-312; 66 DCR 1402), as amended by the Fiscal Year 2020 Budget Support Act of 2019, effective September 11, 2019 (D.C. Law 23-16; 66 DCR 8621), the OLG is charged with licensing and regulating sports wagering in the District of Columbia. In association with implementing its sports wagering licensing and regulation responsibilities, the OLG developed a Sports Wagering and Lottery Licensing System within the DCRA's DC Business Center portal. The following license types are managed within the System:

- (1) Class A Sports Wagering Operator
- (2) Class B Sports Wagering Operator
- (3) Sports Wagering Management Services Provider
- (4) Sports Wagering Supplier
- (5) Sports Wagering Occupational
- (6) Provisional Sports Wagering License
- (7) Lottery Retailer
- (8) Lottery and Sports Wagering Retailer
- (9) Game of Skill
- (10) Charitable Games

Limbic Systems, Inc. will be awarded Contract No. CFOPD-20-C-002 to provide a Sports Wagering and Lottery Licensing System (the System).

Based on the above, it is in the best interest of the District of Columbia and its needs to award this contract to Limbic Systems, Inc.
