1. AUTHORIZATION

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700, 1701 and 2005.6(b)

2. MINIMUM NEED

The Government of the District of Columbia (District) Office of Finance and Treasury (OFT), Central Collections Unit (CCU) has an immediate need for a Contractor to provide Primary Collection Services with respect to student loan and tuition accounts.

3. ESTIMATED REASONABLE PRICE

The estimated fair and reasonable price associated with and budgeted for the contract extension is \$84,000.00 from July 1, 2016 through June 30, 2017. The estimated price is based on projected estimates in addition to previous and/or historic costs for the period of performance and the Contractor's pricing schedule.

4. **FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT**

Continental Service Group d/b/a ConServe was awarded Contract No. PO-GF-2010-C-1090-DJ to provide quality primary collection services for student loan and tuition accounts. The contract term ends June 30, 2016. In preparation for a replacement contract, the Office of Finance and Treasury (OFT), Central Collections Unit (CCU) has developed requirements based on latest trends in the collection services industry. The improved requirements are being procured through a competitive process with an anticipated contract effective date no later than July 1, 2017. The OFT, CCU has a critical need for uninterrupted services due to requirements in the District of Columbia Official Code to collect delinquent accounts due to the University of the District of Columbia. Due to ConServe's capacity for these services, a market survey was not conducted. Therefore, it is necessary to extend the contract through June 30, 2017, to allow for continuity of service and to allow time for the completion of the competitive procurement process for a new contract with modern requirements.
