
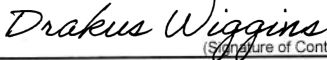

## ATTACHMENT A

- A. Based on an upward trend in transactions on District agencies' online payment portals, this Modification 5 changes the first paragraph of Section 3e, Not-To-Exceed of Schedule A of the Agreement as follows to modify the not-to-exceed amounts:
- e. This Agreement is requirements contract in accordance with Title 27 of the D.C. Municipal Regulations, Section 2416. You will purchase your requirements of the services included herein from the us. The estimated, not-to-exceed amount of the Agreement is \$900,000 for the base period and \$1,600,000 for the option periods, if exercised. These amounts reflect the best estimate available. The estimate shall not be construed as a representation that the estimated amount will be required or that conditions affecting requirements will be stable. The estimated amount is the maximum limit of our obligation to deliver and your obligation to order.
- B. The Not-to-Exceed amount of Option Year 2, for the period June 6, 2023, through June 5, 2024, is hereby increased from \$1,200,000 by \$400,000 to \$1,600,000.
- C. The cumulative not-to-exceed amount of the Contract is increased from \$3,000,000.00 by \$400,000 to \$3,400,000.
