CHANGE-OF-NAME AGREEMENT

Verus Analytics LLC (Contractor), a corporation duly organized and existing under the laws of the State of Delaware, and the Office of the Chief Financial Officer, Office of Contracts for the District of Columbia (Government), enter into this Agreement as executed by the Contracting Officer.

- 1) The parties agree to the following facts:
 - a) The Government, represented by various Contracting Officers of the Office of Contracts, has entered into certain contracts with Verus Analytics LLC, namely:
