


The District intends to achieve the following with Modification 7:				
A. Pursuant to 27 DCMR Chapter 2008 and Section F.2., Option to Extend the Term of the Contract, contained in the contract and Modification 5 of the contract, the District hereby exercises the remainder of Option Year Two for the period of May 1, 2023 through March 30, 2024. The funding for the totality of Option Year 2 is not to exceed \$315,320.00. Based on Modification 5, the cumulative value of the contract is increased from \$1,181,827.00 by \$315,320.00 to a new cumulative total amount not to exceed \$1,497,147.00.				
B. All other terms and conditions shall remain unchanged.
