ATTACHMENT A

1. To correct the cumulative value of the contract, Paragraph A of Modification 6 is deleted in its entirety and replaced with the following:

Pursuant to Section F.2 – Options to Extend, the District hereby exercises the remainder of Option Period Two for the period of June 1, 2021 through May 31, 2022. The funding for the twelve (12) month Option Period Two is not to exceed \$287,172.00. The cumulative value of the contract is increased by \$287,172.00 to an amount not to exceed \$871,046.00.

2. To correct the cumulative value of the contract, Paragraph A of Modification 10 is deleted in its entirety and replaced with the following:

Pursuant to Section F.2 – Options to Extend, the District hereby exercises the remainder of Option Period Three for the period of July 1, 2022, through May 31, 2023. The funding for the twelve (12) month Option Period Three is not to exceed \$287,172.00. The cumulative value of the contract is increased by \$287,172.00 to an amount not to exceed \$1,158,218.00.
