1. AUTHORIZATION

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700, 1701 and 2005.6(b)

2. MINIMUM NEED

The Government of the District of Columbia (District) Office of Finance and Treasury (OFT), Central Collections Unit (CCU) has an immediate need for a Contractor to provide Secondary Collection Services with respect to student loan and tuition accounts.

3. ESTIMATED REASONABLE PRICE

The estimated fair and reasonable price associated with and budgeted for the contract extension is \$50,000.00 from February 1, 2016 through November 30, 2016. The estimated price is based on projected estimates in addition to previous and/or historic costs for the period of performance and the Contractor's pricing schedule.

4. **FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT**

Williams & Fudge, Inc. was awarded Contract No. PO-GF-2010-C-1089-DJ to provide quality secondary collection services for student loan and tuition accounts. The contract term ends January 31, 2016. In preparation for a replacement contract, the Office of Finance and Treasury (OFT), Central Collections Unit (CCU) has developed requirements based on latest trends in the collection services industry. The improved requirements are being procured through a competitive process with an anticipated date for commencement of services no later than December 1, 2016. The OFT, CCU has a critical need for uninterrupted services due to requirements in the District of Columbia Official Code to collect delinquent accounts due to the University of the District of Columbia. Due to Williams & Fudge, Inc.'s capacity for these services, a market survey was not conducted. Therefore, it is necessary to extend the contract through November 30, 2016, to allow for continuity of service and to allow time for the commencement of services through a new contract with modern requirements and capabilities.
