The following is the response to inquiry received.

Questions 1. Section L.3.3 page 74, RFP says, "A detailed narrative that describes the Offeror's budget methodology, detail cost factors, and the proposed MSP Fee represented as a percentage." Can OCFO provide clarification about budget methodology and detailed cost factors since OCFO provided the rates?

Response 1. A response to these inquiry is provided as this inquiry was submitted timely in accordance with Section L.2.1 of the RFP, as amended; however, the inquiry was inadvertently omitted from the OCFO's prior amendment due to administrative oversight.

The OCFO expects a narrative of the budget methodology and detailed cost factors to explain the proposed MSP Fee.
