The following are responses to inquiries received.

- Question 1. Section C.3.4 - Would the District please advise whether or not the Medicaid CASSIP population requires a medical loss ratio where the scope of work for this section should align more with the scope of work outlined for other MCO audit services within sections C.3.6-9(b) to ensure compliance with the financial data component of the periodic audit requirement per 42 CFR 438.602(e)?
- Response 1. Yes, the CASSIP contract has a separate medical loss ratio which is different from the medical loss ratio determined for the audits set forth in Sections C.3.6-C.3.9.
