The District intends to achieve the following with Modification 8: A. Pursuant to 27 DCMR Chapter 2008 and Section F.2., Option to Extend the Term of the Contract, contained in the contract and Modification 5 of the contract, the District hereby exercises Option Year Three for the period of March 31, 2024 through March 30, 2025. The funding for Option Year 3 is not to exceed \$430,722.00 (based on the Contract § B.5.2.d – Option Year Three and Modification 5 § B.4.4 – Option Year Three). The cumulative value of the contract is increased from \$1,497,147.00 by \$430,722.00 to a new cumulative total amount not to exceed \$1,927,869.00. B.
