**FINDINGS**

**1. AUTHORIZATION:**

D.C. Municipal Regulations Title 27 §3307 and PPRA §419

**2. MINIMUM REQUIREMENTS:**

The Government of the District of Columbia (District), Office of Lottery & Gaming (Agency OLG) has a minimum need for maintenance services of the Sports Wagering and Lottery Licensing System.

**3. ESTIMATED REASONABLE PRICE AND REASONABLENESS DETERMINATION:**

The estimated contract total price is \$629,370.00

Contract Specialist Reasonableness Determination:

- (a) The cost of this contract is of a type generally recognized as ordinary and necessary for the conduct of the contractor or the performance of the contract.
- (b) This contract includes the restraints or requirements imposed by generally accepted sound business practices, arms-length bargaining, federal and District laws and regulations, and contract terms and specifications.

The Office of Lottery and Gaming Director has performed a cost analysis to determine the reasonableness of the price and has found that the price is fair and reasonable.
