**1. AUTHORIZATION**

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700, 1701 and 2005.6(b)

**2. MINIMUM NEED**

The Government of the District of Columbia (District), Office of the Chief Financial Officers, Office of Finance and Treasury (OFT) has an immediate need for continuing services of a contractor to provide secondary collections services for photo enforcement, parking, and moving tickets issued within the District of Columbia.

**3. ESTIMATED REASONABLE PRICE**

The estimated fair and reasonable price to extend the contract six months for the service period of October 1, 2015 through March 31, 2016 is \$2,100,000.00. The estimated reasonable price is based on the contractor's rate and OFT's estimated usage. The contractor's rate is determined fair and reasonable as the rate for the period is a negotiated reduction from the rate awarded in the original contract.

**4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT**

A. Industrial Bank, N.A. is the incumbent contractor and has satisfactorily provided the requested service for over eight (8) years under Contract No. DCKV-2007-C-0001. The contract was competitively awarded on June 13, 2007 to Industrial Bank, N.A. who responded to the preceding solicitation and was deemed qualified to provide all the requirements and the best value to the District. The contract term included a two (2) year base and three (3) one (1) year options. The District extended the term of the contract through September 30, 2015.

- B. OFT's Central Collection Unit (CCU), through the OCFO Office of Contracts, awarded a contract on July 24, 2015 to provide Delinquent Collection Services for the District, on behalf of the CCU, to include DMV delinquent debts. During this implementation and transition period, DMV's Ticket Processing and Services contractor will be programming enhancements to the DMV's system to provide for real-time processing and interfacing with the CCU's Accounts Receivables System and working to complete its interface with Delinquent Collection Services contractor.
- C. All implementation and programming requirements must be completed and tested and for the CCU's Delinquent Collection Services to "Go-Live" no later than April 1, 2016.
- D. The District requires continuity of services as the work is highly visible to the public and ensures District residents and visitors have an effective and efficient way to pay traffic violations through the DMV web portal, the District can track timely payments, and thus provide ongoing services to customers. The contractor is uniquely qualified with demonstrated performance and the capacity to provide immediate and consistent services; as such, a market survey was not conducted.
- E. Therefore, it is necessary for the contract to be extended up to March 31, 2016 to allow for continuity of service and to allow time for the completion of the competitive procurement process for a new contract that best meets the District's needs and for transition of services to the enhanced requirements.
