


The District intends to achieve the following with Modification 8:					
A. Pursuant to Section F.2 – Options to Extend, contained in the contract, the District hereby exercises Option Year Four for the period of January 24, 2026 through January 23, 2027. The funding for this period is not to exceed the total amount of Option Year 4 of \$312,344.76. The cumulative value of the contract is increased from \$1,075,695.19 by \$312,344.76 to an amount not to exceed \$1,388,039.95.
