The District hereby makes the administrative changes to correct the clerical error to the Contract's effective date and the period of performance for the Option Years. 1. The Contract cover page Box #3, Effective Date, is hereby amended to read "See 20C" which confirms the contract effective date as December 20, 2019, based on the date of the Contracting Officer's signature. 2. The Option Year 1 period of performance is hereby amended to correctly reference as December 20, 2020, to December 19, 2021. 3. The Option Year 2 period of performance is hereby amended to correctly reference as December 20, 2021, to December 19, 2022. B.
