


14. Description of Amendment/Modification (Organized by UCF Section headings, including solicitation/contract subject matter where feasible.) The District intends to achieve the following with Modification 3: A. Pursuant to Section F.2 – Option to Extend the Term of the Contract, contained in the contract, the District hereby exercises Option Year 2 for the period of May 4, 2024 through May 3, 2025. The funding for this period is not to exceed \$285,938.30. The cumulative value of the contract is hereby increased from \$392,687.65, by \$285,938.30 to an amount not to exceed \$678,625.95. B. The District hereby modifies the Contract as described in Attachment A. C. All other terms and conditions shall remain unchanged.

ATTACHMENT A

A. Section C.2.3 is deleted and replaced to read as follows:

Annually, DC Lottery participates in approximately 75 - 100 events throughout the year. This includes midday promotions which occur weekly from January through December and community events like the BBQ battle and/or streetscape festivals such as the H Street Festival. Security may be provided at events to protect DC Lottery staff and assets.

B. Section C.3.1 is deleted in its entirety and replaced as the following:

The Contractor shall perform sales and product promotional support at external events throughout the city for the DC Lottery. The Contractor shall sell lottery products at events, community programs, retail stores and promotional activities as directed by the Lottery. DC Lottery will provide equipment, inventory and uniforms as needed; however, the Contractor may also purchase at their own cost and provide uniforms, but they must be approved by the lottery in advance.

C. The Contractor is required to provide the following additional requirements under Section C.3. for all Option Years.

C.3.8 The Contractor shall maintain a Lottery Sales Agent License during the term of the contract and any extensions thereof.

C.3.9 All lottery ticket transactions are subject to the requirements set forth in D.C. Code §§ 36-601.15 through 36- 601.16, and District of Columbia Municipal Regulations, Title 30, chapters 30-2 and 30-3.

C.3.10 The Contractor shall only accept cash or debit cards for the sale of lottery tickets in conformance with Title 30, District of Columbia Municipal Regulations § 308.1(b), which states the following:

308.1(b) Accept only cash or debit cards for the sale of lottery tickets.

- (1) Agents are not required to accept debit cards for the sale of lottery tickets, but if an Agent chooses to accept debit cards, the Agent shall be responsible for any costs, fees or charge backs that may be associated with debit card lottery sales.
- (2) Agents may not charge a fee associated with accepting debit cards for lottery ticket sales.
