

Paragraph F.1 – Term of Contract, is deleted in its entirety and replaced with the following:  The term of the contract shall be from the Contract Effective Date through September 30, 2023.  B. Pursuant to Section F.2 – Options to Extend, contained in the Contract, the District hereby exercises Option Year 1 for the period of October 1, 2023 through September 30, 2024. The funding for Option Year 1 is not to exceed \$62,000.00. The cumulative value of the contract is increased by \$62,000.00 to an amount not to exceed \$101,000.00.  C. All other terms and conditions shall remain unchanged.
