The funding for the Option Year 4 period is not to exceed \$500,000.00. The cumulative value of the contract is increased from \$2,988,000.00 by \$500,000.00 to an amount not to exceed \$3,488,000.00.  B. All other terms and conditions shall remain unchanged.
