Dear Mr. Delehanty:

You are hereby notified that the subject Contract is hereby terminated, effective January 25, 2019, in whole, for the convenience of the Government of the District of Columbia (District) Office of the Chief Financial Officer (OCFO), in accordance with Section I.10, Termination for Convenience of the Contract and Title 27 of the D.C. Municipal Regulations (DCMR) §3702.

The subject Contract was awarded to Delehanty Consulting LLC (Contractor) on May 08, 2018, with the scope of work to provide Gaming System Procurement Consulting Services. The District has determined to no longer require services under the Contract.

The Contract is a Requirements type contract in which the services are provided upon issuance of a task order. All services ordered under the Contract were completed and the Contractor has been paid in full for services rendered. Therefore, this termination for convenience involves no settlement costs.

In conjunction with this notification, the Contractor is required do the following:

1. Stop issuing subcontracts pertaining to the terminated contract, if any;
2. Terminate all subcontracts related to the terminated contract;
3. Promptly notify the contracting officer in writing of any legal proceedings growing out of any subcontract or other commitment related to the terminated contract or in which


a lien has been or may be placed against termination inventory to be reported to the District;

4. Settle any outstanding liabilities and proposals arising out of the termination of subcontracts and obtain any necessary approvals from the Contracting Officer;
5. Immediately advise the Contracting Officer of any special circumstances precluding the stoppage of work; and
6. Take necessary or directed action to protect and preserve property in the Contractor's possession in which the District has or may acquire an interest and, as directed by the Contracting Officer, deliver the property to the District.


No settlement proposal shall be submitted to the Contracting Officer by, or on behalf of, the Contractor as a result of this termination.

This notice constitutes the District's decision that the subject contract is terminated for convenience and that you have a right to appeal this decision under the Disputes provision of Section I.7 of the Contract and 27 DCMR §3800.
