**1. AUTHORIZATION**

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700, 1701 and 2005.6(b)

**2. MINIMUM NEED**

The Government of the District of Columbia (District) Office of Tax and Revenue (OTR) has an immediate need for a high quality Contractor possessing sound knowledge and experience in providing Oracle Managed Cloud Services and Maintenance.

**3. ESTIMATED REASONABLE PRICE**

The estimated fair and reasonable price associated with and budgeted for the contract extension is \$485,000.00 from August 31, 2016 through August 30, 2017. The estimated price is based on projected expenditures for the period of performance and the Contractor's pricing schedule.

4. **FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT**

The Office of the Chief Information Officer currently utilizes the Oracle Managed Cloud Services with Oracle America, Inc. The current awarded Contract No. CFOPD-10-C-045 is to provide quality hosting and maintenance for the new financial system intended to replace the District of Columbia's System of Accounting and Reporting (SOAR). The contract term terminates, August 30, 2016. Because the system implementer appealed the termination of the contract and the appeals process is currently on-going, the District is required, per the opinion of the Assistant Attorney General in the Office of the Attorney General, to preserve the non-production and production environments hosted by Oracle Managed Cloud Services to ensure those environments are available for examination until the appeals process is completed or a settlement with the system implementer is reached. Failure to preserve these environments will result in penalties imposed to the OCFO by the Contracts Appeals Board (CAB). The Office of the Chief Information Officer (OCIO) has a critical need for services to be uninterrupted. Due to Oracle America's capacity for these services, a market survey was not conducted. Therefore, it is necessary to extend the contract through August 30, 2017, to allow for continuity of service and to allow time for the litigation of the case to be decided and adjudicated.
