1. Delete: Section B.1.1 in its entirety and replace as follows:

Section B.1.1

The procurement rules under CFO Order Number 03-002 shall govern this contract (“contract”) and the task orders issued pursuant to this contract. The services required hereunder are exempt from the District of Columbia Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-351.01 *et seq.*) and the regulations promulgated thereunder, including DCMR Title 27. The District will issue task orders in accordance with Section G.9.
