

Pursuant to Section 6.2 – Option to Extend the Term of the Contract, the District hereby exercises Option Year 1 for the period of June 29, 2019 through June 28, 2020. The funding for this period is not to exceed \$565,832.48 for 1,265 Server-Web Client Interactor Licenses at \$348.84 and 182 DeskTop-Professional Licenses at \$684.34. The value of the contract is increased by \$565,832.48 to an amount not to exceed \$991,598.83.  B. All other terms and conditions shall remain unchanged.
