


Pursuant to Section F.2 – Option to Extend the Term of the Contract, contained in the contract, the District hereby exercises the remainder of Option Year Two for the period of December 1, 2021 through October 31, 2022. The funding for this period is \$1,000.00; the minimum dollar value for period. B. Additional funding may be secured at the time of Task Order issuance; however, the maximum dollar value for the period shall not exceed \$950,000.00. The cumulative, maximum not to exceed value of the contract is increased by \$950,000.00 to an amount not to exceed \$2,850,000.00. C. All other terms and conditions shall remain unchanged.
