The following changes are hereby incorporated into the solicitation:

1. The proposal due date and time for the subject solicitation is hereby revised from TBD to **Wednesday, October 21, 2020 by 2:00pm (EST)**.
2. The Department of Small and Local Business Development Director approved waiver of the certified business enterprises (“CBE”) subcontracting requirements of D.C. Code § 2-218.46 for the base year of the resultant contract. As such, the subSection H.3.17 is **ADDED** to Section H.3 as follows:

H.3.17 Notice of Approved Waiver

A waiver has been approved by the Director of the Department of Small and Local Business Development for the base period of the resultant contract. Therefore, the Section H.3.3, requirement to submit a subcontracting plan as part of a Beneficiary’s bid or proposal, **IS NOT** applicable. However, the certified business enterprise subcontracting requirements of Section H.3 **IS** applicable to option periods, if exercised, for Beneficiaries of all non-construction contracts for government-assisted projects in excess of \$250,000, unless a waiver for said option period has been approved in advance by the Director of the Department of Small and Local Business Development.
