


Modification 8
CFOPD-18-C-006 – Kiosks

- A. The Contractor shall reallocate the second kiosk identified for UDC (Section C.4.3) to the Metropolitan Police Department (MPD).
- B. Section C.4.3 is **DELETED** in its entirety and **REPLACED** with the following:

*“C.4.3 The Contractor shall provide kiosks for the following District Agency location at the quantity identified:

Metropolitan Police Department, 301 C Street, NW (Two (2) kiosks)”*
- C. The Contractor shall provide the services in accordance with Change Order Number CODC-6 dated October 9, 2020.
- E. The amount for reallocating the kiosk is \$3,954.50, which covers \$2,000.00 for the one-time installation fee; \$887.50 for a cashbox; and \$1,067.00 for a cassette pack.
- F. Option Year One of the contract is being increased by \$3,954.50 from \$76,800.50 to \$80,755.00.
