2. MINIMUM NEED

The Government of the District of Columbia (District) Lottery & Charitable Games Control Board (DCLB) has an immediate need for continuing a fully integrated, end-to-end solution for the creation, production, distribution and marketing support for instant ticket products.

3. ESTIMATED REASONABLE PRICE

The estimated fair and reasonable price budgeted for the contract extension is \$300,000 from August 17, 2012 through December 31, 2012. The estimated price is based on projected expenditures for the period of performance and the contractor's price schedule.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

Scientific Games International, Inc. (SGI) was awarded Contract No. CFOPD-05-C-904 to provide the personnel, materials, equipment, and facilities to design and produce quality tickets and related services for gaming activities operated by DCLB. The contract term ends August 16, 2012.

In preparation for a replacement contract, DCLB is developing requirements based on latest trends in the gaming industry. The improved requirements will be procured through a competitive process with an anticipated contract effective date of January 1, 2013. The

District has a critical need for uninterrupted services, as DCLB operates ongoing gaming activities under the contract to maximize District revenue. SGI is the only vendor with the capacity to provide immediate and consistent services; as such, a market survey was not conducted.

Therefore, it is necessary to extend the contract through December 31, 2012, to allow for continuity of service and to allow time for the completion of the competitive procurement process for a new contract with modern requirements.
