

**ITEM 1**

- A. Pursuant to 27 DCMR Chapter 2008 and Section F.1.2 – Options to Extend, contained in the Contract, the District hereby exercises Option Year 3 for the period of August 27, 2021 through August 26, 2022. The funding and quantity of hours for this period shall be secured on an as-needed basis, pursuant to Section B.4.1. As such, the Contractor has no obligation to provide personnel until such time as the District determines the actual quantity of hours for the period. The funding for this period is not to exceed \$136,163.60. The cumulative value of the contract is increased to an amount not to exceed \$1,166,573.60.
