


Amendment Re: Cash and Collateral Accounts**

This Amendment (“**Amendment**”) is between Clearwater Analytics, LLC (“**Clearwater**”) and the District of Columbia Office of the Chief Financial Officer (“**Client**”) and amends the May 22, 2020 Order Form, as executed pursuant to the Master Service Agreement by and between Clearwater and Client (the “**Agreement**”).

The parties agree as follows:

1. The following definitions and rates are added to Article 2—Fees:


<b>Cash Discount Fee</b>	0.5000 bp  <i>Cash Discount Fee replaces Core Clearwater Fees for assets held in cash by Client. In order for Cash Discount Fee to apply, such cash assets must be housed in separate accounts.</i>

<b>Collateral Accounts Fee</b>	0.6500 bp  <i>Collateral Accounts replaces Core Clearwater Fees for collateral accounts as mutually agreed to and identified by Client and Clearwater. In order for Collateral Accounts Fee to replace Core Clearwater Fees, all such assets must be agreed to by both parties as Collateral Accounts and must be housed in separate accounts.</i>
