


Pursuant to Section F.2 – Option to Extend the Term of the Contract, contained in the contract, the District hereby exercises Option Year 1 for the period of April 24, 2021 through April 23, 2022. The funding for this period is \$1,000.00; the minimum dollar value for the period.  B. Additional funding may be secured at the time of Task Order issuance; however, the maximum dollar value for the period shall not exceed \$250,000.00. The cumulative, maximum not to exceed value of the contract is increased by \$250,000.00 to an amount not to exceed \$500,000.00.  C. All other terms and conditions shall remain unchanged.
