1. **AUTHORIZATION**

2. MINIMUM NEED

The District of Columbia Office of the Chief Financial Officer (OCFO), Office of Finance and Treasury has a need for a qualified Contractor to provide professional temporary personnel support services to augment staff for various audit requirements.

3. ESTIMATED REASONABLE PRICE

The estimated fair and reasonable contract amount for this extension period from February 20, 2020 through February 19, 2021 is not-to-exceed \$750,000.00, based on the Contractor's rate and District estimated usage. The contractor's pricing was determined fair and reasonable based on market research and historical data gathered and analyzed by the Office of Finance and Treasury.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

NRI Staffing Resources is the incumbent Contractor and has satisfactorily provided the required services for five (5) years under contract CFOPD-15-C-026. The contract was competitively awarded on February 20, 2015 to NRI Staffing Resources who responded to the solicitation and was deemed qualified to provide all the requirements and the best value to the District of Columbia. The contract term included a one (1) year base period with four (4) one (1) year option periods. During the contract term NRI Staffing

Resources has provided professional temporary personnel support staff to assist and augment the Office of Finance and Treasury's permanent staff to ensure that various auditing requirements are met. Positions have included but are not limited to Debt, Investment, Financial and Banking Management Analysts as well as Collections Representatives and Accounting Technicians.

The District has a critical need for uninterrupted services for the positions for continual auditing requirements.

A sole source extension is the most advantageous method of fulfilling the District's need while completing the competitive procurement process and to allow time for a transition period from the existing contractor to a new contractor, if necessary. A market survey was not conducted because NRI Staffing Resources has agreed to continue services based on existing contract pricing.

Therefore, it is necessary to extend the contract through February 19, 2021 to facilitate and allow continuity of critical personnel augmentation services for audit requirements for the District.

The Office of Contracts expects to award a new contract on or before February 19, 2021.
