# 2. <u>MINIMUM NEED</u>

The Government of the District of Columbia (District) Office of Budget and Planning (OBP) has an immediate need for a high quality Contractor possessing sound knowledge and experience in publishing designed, bound reports and producing CD ROMs. The Contractor must present a flexible printing schedule in working with the Office of Budget and Planning and the Office of Financial Operations and Systems. The schedule shall include nights and weekends in presenting drafts of the Budget for review and to format and print the final report as specified by the District. The Contractor must be able to meet the strict timelines for the District and be able to deliver the final reports on time and within costs. # 4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

Balmar, Inc. was awarded Contract No. CFOPD-09-C-004 to provide quality printing and publishing services. The contract term ends June 30, 2014. In preparation for a replacement contract, the Office of Budget and Planning and the Office of Financial Operations and Systems are developing requirements based on latest trends in the printing/publishing industry. The improved requirements will be procured through a competitive process with an anticipated contract effective date of October 1, 2014. The District has a critical need for uninterrupted services due to the OCFO, DC Council and U.S. Congress deadlines for the Comprehensive Annual Financial Report and the Annual Budget Books and Balmar, Inc. is the only vendor with the capacity to provide immediate and consistent services. Due to Balmar, Inc.'s capacity for these services, a market survey was not conducted. Due to the foregoing, it is necessary to extend the contract through September 30, 2014, to allow for continuity of service and to allow time for the completion of the competitive procurement process for a new contract with modern requirements.


