

**The following responses to inquiries are hereby provided.**

Question 1. SOW Clarity: Is a major goal of this request to:

a. Train staff of OLG to conduct criminal and non-criminal background investigations and public records searches on a national database, with the ability to handle in-depth searches in local jurisdictions as needed?

OR

b. Provide OLG Staff with the training to conduct full, in-house criminal background checks within all jurisdictions nationwide? This would be a larger scale training program, though we have the background and personnel to handle both.

Response 1. The requirement is to train staff of OLG to conduct criminal and non-criminal background investigations and public records searches on a national database, with the ability to handle in-depth searches in local jurisdictions as needed.

Question 2. What additional materials about our business are we permitted to submit (electronically) including brochures and power point presentations?

Response 2. Bidders shall provide documents listed in Section L.3.2. Any additional materials submitted will not be considered for award.

Question 3. Is a business license with DC required to submit a bid?

Response 3. A business license with DC is not required to "submit a bid"; however, it is required prior to and for a bidder to be eligible for an award. A vendor may obtain a business license with DC at any time.
