2. MINIMUM NEED

The District of Columbia, Office of the Chief Financial Officer (OCFO), has an on-going requirement for a Contractor to provide Prepaid Debit Cards and associated services.

4. FACTS WHICH JUSTIFY SOLE SOURCE EXTENSION OF CONTRACT

US Bank is the incumbent contractor and has satisfactorily provided the required services for five (5) years under Contract CFOPD-17-C-017. The contract was awarded on February 7, 2017 with a one (1) year base period and four (4) one (1) year option periods.

It is imperative that this contract be extended to ensure that the services provided to many District agencies, such as the Department of Employment Services, Child and Family Services Administration, Office of Payroll and Retirement Services and Department of Health and Human Services, to name a few, remain in place and uninterrupted.

The incumbent contractor, US Bank Corporation, is the only contractor with historic knowledge and the capacity to provide continuous and uninterrupted services for the various Prepaid Debit Card Programs throughout the city at this time. Sufficient time must be allowed for the development and processing of a new procurement for these services as well as ample time for a smooth transition to a new vendor with updated and advanced services capabilities. In order to facilitate this new acquisition and maintain uninterrupted Prepaid Debit Card Services, the contract shall be extended through February 6, 2023.

The Office of the Chief Financial Officer has a critical need to maintain uninterrupted Prepaid Debit Card capabilities and these services, furnished and administered by US Bank Corporation are an intrinsic and integral part of the OCFO customer service commitment to District residents and it is critical that they are continuous and sustained.

As a result of the foregoing, it is necessary and prudent to extend Contract CFOPD-17-C-017 through February 6, 2023 to allow for continuity of services, execution of a new contract award and potential transition to a new contractor.
