FINDINGS

1. AUTHORIZATION:

D.C. Municipal Regulations Title 27 §3307 and PPRA §419

2. MINIMUM REQUIREMENTS:

The estimated contract total price is \$941,751.98.

- (f) The pricing contained in this contract is based on DC Supply schedule contract CW59303 and is been determined as fair as reasonable at the time of the award.


4. JUSTIFICATION OF REASONABLENESS OF PRICE:
