1. **AUTHORIZATION**

D.C. Official Code §2-354.04; 27 DCMR §§ 1304, 1700, 1701 and 2005.6(b), PPRA 404

2. MINIMUM NEED

The Government of District of Columbia (District), Office of Finance and Treasury (OFT), Central Collections Unit (CCU) has immediate need for a Contractor to provide Primary Collection Services to collect medical and hospital bad debt self-pay accounts receivable that the hospital has attempted to collect, but has been unsuccessful. These accounts have been deemed uncollectible, so that the patient account information can now be transmitted to a company, who will attempt to collect these accounts for the hospital.

3. ESTIMATED REASONABLE PRICE

The estimated fair and reasonable price associated with and budgeted for the contract extension is \$100,000.00 from October 1, 2019 through September 30, 2020. The estimated price is based on projected estimates in addition to previous and/or historic costs for the period of performance and the Contractor's pricing schedule.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

- A. Nationwide Recovery Service. Inc. is the incumbent contractor and has satisfactorily provided the requested service for over seven (7) years under Contract No. 12-C-034. The contract was competitively awarded on August 10, 2012 to Nationwide Recovery Service. Inc. who responded to the preceding solicitation and was deemed qualified to provide all the requirements and the best value to the District. The contract term included a one (1) year base and four (4) one (1) year options. The District has extended the term of the contract through September 30, 2019.
- B. In preparation for replacement services, the OCFO awarded a replacement contract based on the latest District legislation regarding debt collections. The contract requires a period for transition of services to the enhanced requirements. The commencement of the new contract service requirements may begin October 1, 2020 due to the necessary period to transition services to the enhanced requirements. As such, the current contract is proposed to be extended for a three (3) month period, and provide the District at its sole discretion, to further extend the period of the contract for up to three (3), three (3) month optional periods. Therefore, the total extension of the contract is 12 months, in the event all options are exercised. The District has a critical need for uninterrupted services, as the contractor provides primary collections services for the University of the District of Columbia and remits the revenue directly to the District.
- C. The District requires continuity of services as the work is visible to the public and ensures District revenue for the University of the District of Columbia. The contractor is uniquely qualified with demonstrated performance and the capacity to provide immediate and consistent services; as such, a market survey was not conducted.
- D. Therefore, it is necessary for the contract to be extended from October 1, 2019 up to September 30, 2020 to allow for continuity of service and for transition of services to the enhanced requirements.
