1. <u>AUTHORIZATION</u>

D.C. Official Code §2-354.04, 27 DCMR § 1702, PPRA § 404

2. MINIMUM NEED

The Government of the District of Columbia (District) Office of the Chief Financial Officer, Office of Revenue Analysis (ORA) has a need for commercial real estate information and analytic services.

3. <u>ESTIMATED REASONABLE PRICE</u>

The estimated fair and reasonable price budgeted for the contract is approximately \$66,643.50 for a one year period of performance based on historical data.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

CoStar Group (CoStar) is a national company that is the industry leader in data regarding the status of office buildings—how many, size, occupancy, ownership, history, tenants, vacancy rates, rents, under construction, etc. For the District of Columbia, data is available by 9 sub-locations, such as the Central Business District, East End, Capitol Riverfront, etc. The CoStar data is contained in a web-based interactive system that allows the user to specify location, size, and other characteristics. Because commercial real estate is such a major component of the DC real estate tax base, the ability CoStar gives to examine past trends and real property coming on-line over the next several years provides essential insight into this element of the tax base. In addition, the detail on specific buildings (or groups of buildings), including their size, when they were built, their tenants, and when they were last sold, assists ORA in preparing fiscal impact statements regarding tax increment financing areas, tax abatements, or development support. The CoStar system comes with user support and training.

ORA has been using this service for the analysis of our commercial property evaluations in the District and it is an essential tool that is used in the final formulation of the revenue projections every quarter. The products and services that ORA utilize are research tools and not simply tools that can be obtained from shelves or multiple sources. They are unique and analytical. It would not be possible for ORA to ask for quotes from sources that may not even exist, as such a market survey was not conducted.

Therefore, it is in the District's best interest to award a contract to CoStar as a sole source.
