The following changes are hereby incorporated into the solicitation.

- 1. Section L.2.1 is hereby amended to extend the deadline for inquiries to December 27, 2021, 2:00PM (EST).
- 2. Section H.3.16 is hereby deleted in its entirety, as the COVID-19 emergency 50% CBE subcontracting requirement has expired. The 35% CBE subcontracting requirement remains unchanged.

Attachment B

The following are responses to inquiries received.

- Question 1. B.6 may this be completed and supplied as an excel document?
- Response 1. No. Per Section L.3.1, the District may reject as non-responsive any bids submitted on forms not included in or required by the solicitation.
 - Per Section L.3.2 Bidders shall complete and provide, as its bid submission, among other documents, Completed Section B, Price Schedule.
- Question 2. I was working to understand if DC has done business with [vendor] in the past, but I am unable to locate any data, can you advise as to what Account might be associated with this?
- Response 2. The OCFO's prior stored value gift cards contracts are: CFOPD-14-C-040 and CFOPD-20-C-007, and the contracts can be downloaded from: https://dc.cobblestonesystems.com/public/default.aspx
- Question 3. We would like to clarify one point before proceeding: can the District please indicate if the subcontractor requirement is in effect for this solicitation? Are vendors only eligible to participate if they meet the terms as described in section H.3 (Certified Business Enterprise Subcontracting Requirements) of the solicitation? Likewise, is the 51% resident requirement in effect for this solicitation? Are vendors only eligible to participate if they meet the terms as described in section I.31 (District Residents) of the solicitation?
- Response 3. In accordance with Section H.3 of the IFB, certified business enterprise subcontracting requirements does apply to this solicitation.

The 50% CBE requirement expired November 5, 2021, despite the fact that the COVID-19 emergency was extended to January 7, 2022. Therefore, if a non-CBE Offeror's bid for the Base Year is in excess of \$250,000, the non-CBE Offeror must subcontract at least 35% of the dollar volume of the contract to a CBE (certified business enterprise, certified by the D.C. Department of Small and Local Business Development). In this instance, the non-CBE Offeror must submit an Attachment J.5, Subcontracting Plan fully completed in accordance with Section H.3.4 of the IFB. A CBE Offeror is only required to subcontract to CBEs in accordance with Sections H.3.2(a) and H.3.2(c), if the CBE Offeror choices to subcontract. The CBE Offeror must submit an Attachment J.5, Subcontracting Plan fully completed in accordance with Section H.3.4 of the IFB.

A request for waiver of Subcontracting Requirements must be submitted in accordance with Section H.3.12 no later than the deadline stated in the section.

- Response 7. - Question 8. To confirm, can the reference to task order in the requirements be the fulfiller's ordering system?
- Response 8. Yes, if the ordering system meets the terms and conditions in the solicitation without imposing additional terms and conditions. The Offeror should handle any questions, exceptions, or alternatives it wishes to present to the District, or assumptions relative to this solicitation, as a submitted inquiry to the District in accordance with Section L.2; not as a condition in its bid. In accordance with L.12.4, it may take two (2) business days to receive credentials to Login to the Gateway, but nonetheless, the response due date will not be changed while an offeror receives Gateway Login credentials.
