## 1. <u>AUTHORIZATION:</u>

D.C. Municipal Regulations Title 27 §1540.1 and 2200; PPRA §301 and 302

### 2. MINIMUM REQUIREMENTS:

The District of Columbia Office of the Chief Financial Officer, Office of Contracts, on behalf of Office of the Chief Information Officer (OCIO) (the "District") is awarding a contract to provide a SharePoint Online Developer to lead a migration and develop critical business workflows and various solutions in SharePoint Online.

### 3. ESTIMATED REASONABLE COST:

- (f) the necessary organization, experience, accounting and operational controls, and technical skills, or the ability to obtain them;
- the necessary production, construction, and technical equipment and facilities (g) or the ability to obtain them;
- not exhibited a pattern of overcharging the District; (h)
- the contractor does not have an outstanding debt with the District or Federal (i) government in delinquent status of more than the greater of \$1,000 or 1% of the contract value, up to \$25,000; and
- the contractor is otherwise qualified and is eligible to receive an award under (i) applicable laws and rules.
