- not exhibited a pattern of overcharging the District; (h)
- the contractor does not have an outstanding debt with the District or Federal (i) government in delinquent status of more than the greater of \$1,000 or 1% of the contract value, up to \$25,000; and
- (j) the contractor is otherwise qualified and is eligible to receive an award under applicable laws and rules.
