#### 2. MINIMUM NEED

#### 4. FACTS WHICH JUSTIFY SOLE SOURCE EXTENSION OF CONTRACT

Segal Advisors is the incumbent Contractor and has satisfactorily provided the required services for five (5) years under Contract CFOPD-17-C-019A. The contract was awarded on April 27, 2017, with a one (1) year base period and four (4) one (1) year option periods.

It is imperative that this contract be extended to ensure that the services provided, such as fund performance, Investment Policy Statement, recommendations for managers for the Outsourced Chief Investment Officer, asset allocation, trends in the industry, communications, annual report, etc.) remain in place and uninterrupted.

The incumbent contractor, Segal Advisors, is the only contractor with historic knowledge and the capacity to provide continuous and uninterrupted services for the various 40(a) and 457 Benefit plans Consultancy services at this time. Sufficient time must be allowed for the development and processing of a new procurement for these services as well as ample time for a smooth transition to a new vendor with updated and advanced services capabilities. In order to facilitate this new acquisition and maintain uninterrupted Benefit plans Consultancy services, the contract shall be extended through April 26, 2023.

The Office of the Chief Financial Officer has a critical need to maintain uninterrupted Benefit plans Consultancy services, furnished and administered by Segal Advisors are an intrinsic and integral part of the OCFO's commitment to the District employees and it is critical that they are continuous and sustained.

As a result of the foregoing, it is necessary and prudent to extend Contract CFOPD-17-C-019A through April 26, 2023, to allow for continuity of services, execution of a new contract award and potential transition to a new contractor.
