- A. The purpose of this contract Modification is to increase the estimated quantity of captured tax collections for Option Year Four and to exercise Option Year Four.
- B. The estimated quantity of captured tax collections for Option Year Four is increased from \$1,600,000.00 by \$14,500,000.00 to \$16,100,000.00. Therefore, Price Schedule, Section B.4.5, Option Year Four is hereby replaced as follow:
