1. <u>AUTHORIZATION</u>

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700, 1701 and 2005.6(b)

2. MINIMUM NEED

The Government of the District of Columbia (District) Office of Lottery and Gaming (OLG) has an immediate need for the Contractor to continue to provide Lottery Advertising Services for the District of Columbia.

3. <u>ESTIMATED REASONABLE PRICE</u>

The estimated fair and reasonable price budgeted for the contract extension is \$6,516,306.00 from March 3, 2021 through September 2, 2021. The estimated price is based on projected expenditures for the period of performance and the contractor's price schedule.

4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

A. MDB Communications, Inc. is the incumbent contractor and has satisfactorily provided the requested service for over five (5) years under Contract No. CFOPD-16-C-016. The contract was competitively awarded on March 3, 2016 to MDB Communications, Inc. who responded to the preceding solicitation and was deemed qualified to provide all the requirements and the best value to the District. The contract term included a one (1) year base and four (4) one (1) year options. The District has exercised the final term of the contract through March 2, 2021.

- B. In preparation for a replacement contract, OLG developed requirements based on the latest trends in full-service advertising and marketing services. Unexpected circumstances resulted in the cancellation of initial replacement procurement. Subsequently, the improved requirements are being solicited through a competitive process. The resultant contract will require a period for transition of services to the enhanced requirements. The commencement of the new contract service requirements may begin September 3, 2021 due to the necessary period to transition services to the enhanced requirements. As such, the current contract is proposed to be extended for a three (3) month period, and provide the District at its sole discretion, to further extend the period of the contract for another three (3) month optional period. Therefore, the total extension of the contract is six (6) months, in the event the option period is exercised. The District has a critical need for uninterrupted services, as the contractor provides DC Lottery advertising, marketing communications, and public information programs to raise awareness of the Lottery brand, stimulate ticket sales across the Lottery's product lines (traditional lottery, iLottery and sports betting), and reinforce and enhance the image of the Lottery as a fun, innovative, and entertaining revenue source for the General Fund.
- C. The District requires continuity of services as the work is highly visible to the public and is benefiting the residents and the economic vitality of the District of Columbia. The contractor is uniquely qualified with demonstrated performance and the capacity to provide immediate and consistent services; as such, a market survey was not conducted.
- D. Therefore, it is necessary for the contract to be extended from March 3, 2021 up to September 2, 2021 to allow for continuity of service, to allow time for the completion of the competitive procurement process for a new contract that best meets the District's needs, and for transition of services to the enhanced requirements.
