### **FINDINGS**

## 1. **AUTHORIZATION:**

D.C. Municipal Regulations Title 27 §3307 and PPRA §419

## 2. MINIMUM REQUIREMENTS:

The District of Columbia Office of the Chief Financial Officer, Office of Contracts, on behalf of Office of the Chief Information Officer (OCIO) (the "District") is awarding a contract for a Mainframe Support Analyst to provide technical support services to maintain and enhance the mainframe check writing (CheckWrite) and account reconciliation (ARP) systems used by the District and to assist in responding to requests for data from legacy time reporting systems (CAPPS and UPPS).

# 3. <u>ESTIMATED REASONABLE PRICE AND REASONABLENESS</u> <u>DETERMINATION:</u>

The estimated contract total price is \$95,779.84.

Contract Specialist Reasonableness Determination:

- (a) The cost of this contract is of a type generally recognized as ordinary and necessary for the conduct of the contractor or the performance of the contract.
- (b) This contract includes the restraints or requirements imposed by generally accepted sound business practices, arms-length bargaining, federal and District laws and regulations, and contract terms and specifications.
- (c) This action is an action that a prudent business person would take, considering responsibilities to the owner of the business, employees, customers, the District, and the public at large.
- (d) There are no significant deviations from the established practices of the contractor that may unjustifiably increase the contract costs.

- (e) There are no other relevant factors that should be noted at this time.
- (f) A review of rates from historical data for these services indicates that the costs associated with this contract is commensurate with the general market.

## 4. <u>JUSTIFICATION OF REASONABLENESS OF PRICE:</u>

The Contracting Officer has performed a cost analysis to determine the reasonableness of the price and the Contracting Officer has found that the price is fair and reasonable.

The Contracting Officer has compared prices of this contract with the independent District cost estimate and has determined the price to be fair and reasonable.
