- A. Pursuant to Section F.2 Option to Extend the Term of the Contract, contained in the contract, the District hereby exercises Option Year 1 for the period of October 31, 2021 through October 30, 2022. The funding for this period is \$1,000.00; the minimum dollar value for this period.
