The District intends to achieve the following with Modification 3:

- A. Pursuant to Section F.2 Option to Extend the Term of the Contract, contained in the contract, the District hereby exercises Option Year 2 for the period of October 31, 2021 through October 30, 2022. The funding for this period is \$1,000.00; the minimum dollar value for this period.
- B. Additional funding may be secured at the time of Task Order issuance; however, the maximum dollar value for the period shall not exceed \$950,000.00. The cumulative, maximum not to exceed value of the contract is increased by \$950,000.00 to an amount not to exceed \$2,850,000.00.
- C. Section H.1.1 is hereby added as follows and these requirements apply *only* to those District contractors who provide goods or perform services in person in District government facilities or worksites, or who have in-person contact with other persons in order to complete their work under their contract:
