## 2. MINIMUM NEED

The Government of the District of Columbia (District) Office of Finance and Treasury (OFT) has an immediate need for a Contractor to provide custody, securities brokerage and accounting services of securities collected on behalf of the District of Columbia (DC) from holders of abandoned securities.

## 3. ESTIMATED REASONABLE PRICE

There is a $\$ 228,401.25$ cost associated with this extension from November 8, 2016 through October 7, 2017. Price has been determined to be reasonable based on previous competitive pricing submitted at the time of the initial award. The same contract pricing remains during this extension period.

## 4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

Xerox State and Local Solutions, Inc. was awarded Contract No. CFOPD-11-C-043 to provide custody, securities brokerage and accounting services of securities collected on behalf of the District of Columbia (DC) from holders of abandoned securities. The contract term ends November 7, 2016.

In preparation for a replacement contract, the Office of Finance and Treasury (OFT) developed requirements based on the latest trends in the unclaimed property custody and accounting services industry. The improved requirements have been solicited through a competitive process with an anticipated contract effective date on or before October 7, 2017. OFT has a critical need for uninterrupted services due to legislation regarding the District's handling of unclaimed property. Due to Xerox State and Local Solutions, Inc.'s capacity for these services, a market survey was not conducted.

Therefore, it is necessary to extend the contract through October 7, 2017, to allow for continuity of service and to allow time for the award of a new contract with modern requirements.
