#### 1. AUTHORIZATION

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700 and 1701

### 2. MINIMUM NEED

The Office of the Chief Financial Officer ("OCFO") for the District of Columbia ("District") and the Office of Contracts on behalf of the Office of Finance and Treasury (OFT) requires the Contractor to provide Post Conversion Services for the 529 DC College Savings plan from the previous program manager Calvert, to the new program manager Ascensus College Savings.

#### 3. ESTIMATED REASONABLE PRICE

The contract amount is \$134,546.62. The contractor's pricing was determined fair and reasonable based on market research.

## 4. <u>FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT</u>

The Government of the District of Columbia (the "District"), Office of the Chief Financial Officer is charged with administering the District "College Savings Act of 2000" as stated in D.C. Law 13-212, approved March 31, 2001, and as amended, by the College Savings Program Temporary Act of 2002 D.C. Law 14-186, approved October 1, 2002, and the College Saving Program Act of 2002, D.C. Law 14-307 approved June 5, 2003.

The District has a critical need for uninterrupted availability of services, as the District is required by law under D.C Laws 13-212, 14-186, and 14-307 to provide 529 College Savings Plan Services on a consistent basis.

The Office of Finance and Treasure has an immediate need for Post Conversion Services from Boston Financial Data Services (BFDS). BFDS served as the subcontractor to the District's previous provider Calvert and provided record keeping services on behalf of the District. During the transition process Calvert had dissolved as a company and no longer provides the 529 College Plan services. In order for the District to receive the tax reporting information that is required by federal law, a contract must be established with BFDS since they already maintain this information on behalf of the District and this information cannot be obtained by any other contractor. BFDS is the only source that is readily available to perform this essential requirement without interruption of services.

Based on the above justification, it is in the best interest of the District of Columbia that a contract award be made to Calvert Investments.
