## **FINDINGS**

## 1. **AUTHORIZATION:**

D.C. Municipal Regulations Title 27 §3307 and PPRA §419

## 2. <u>MINIMUM REQUIREMENTS:</u>

The District of Columbia Office of the Chief Financial Officer, Office of Contracts, on behalf of the Office of the Chief Information Officer, is seeking to acquire a Specialist to support the day-to-day basic reporting systems and databases for the District's Cognos and Tableau environments. The support includes ongoing design, implementation, and operations of other Web Systems applications. This is position shall be filled to support the overall modernizing efforts of the Districts reporting environment and supporting the Districts current Cognos report environment.

# 3. <u>ESTIMATED REASONABLE PRICE AND REASONABLENESS</u> <u>DETERMINATION:</u>

The estimated contract total price is \$353,600.00.
