# 1. <u>AUTHORIZATION</u>

D.C. Official Code §2-354.04; 27 DCMR 1304, 1700, 1701 and 2005.6(b)

## 2. MINIMUM NEED

The Government of the District of Columbia (District) Office of Finance and Treasury (OFT) has an immediate need for a high quality, expert Contractor possessing sound knowledge and experience in financial and investment advisory services and project execution assistance for the Preparation and Compilation of the Financial Statements for the OPEB (Other Post Employment Benefits) Trust and the audit of the Financial Statements of the 529 College Savings Plan. The Contractor's company shall be a registered investment advisor and/or broker/dealer with the SEC under the Investment Act of 1940. The Contractor shall work in conjunction with District staff members to make sure that all requirements are implemented.

## 3. <u>ESTIMATED REASONABLE PRICE</u>

There is a \$110,000 cost associated with this extension from October 27, 2016 through October 26, 2017. Price has been determined to be reasonable based on previous competitive pricing submitted at the time of the initial award. The same contract pricing remains during this extension period.

# 4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT

Regis & Associates, PC was awarded Contract No. CFOPD-11-C-015 to provide quality financial advisory and project execution services for the Preparation and Compilation of the Financial Statements for the OPEB (Other Post Employment Benefits) Trust and the audit of the Financial Statements of the 529 College Savings Plan. The contract term ends October 26, 2016. The Office of Finance and Treasury is in the process of developing a Request for Proposals to select a new contract award based on latest trends in the financial advisory and investment industry. The award will be made with an anticipated contract effective date of or before October 27, 2017. The District has a critical need for uninterrupted services due to the nature of the OPEB (Other Post Employment Benefits) Trust and 529 College Savings Plan and DC Government Legislation, and Regis & Associates, PC is the only vendor with the capacity to provide immediate and consistent services. Due to Regis & Associates, PC's capacity for these services, a market survey was not conducted. Therefore, it is necessary to potentially extend the contract through October 26, 2017, to allow for continuity of service for the Office of Finance and Treasury and to allow time for the execution of a new contract award.
